- 3. List all the facts that substantiate your claim. Attach any documents you wish to have considered. Recorded on March 6th, candidates Kavi and Naim intentionally placed multiple copies of the same fliers at the Artistic Expression Village and the Language and Communication Village. This is a clear violation of Guideline 10 of the Student Election Posting Guidelines, which states that you may not post multiple fliers for the same candidates in the same location. On March 5th, starting around 10:30 in the Forum 4 classroom, these candidates also blatantly violated the election code by using office supplies, including the whiteboard and dry-erase markers, for their campaign. Kavi and Naim took a classroom-issued dry-erase markers and used them to write their names and ballot numbers on the whiteboard—an undeniable breach of the rules. What makes these violations even more concerning is their knowing use of inflammatory imagery and language tied to communist propaganda and regimes like Joseph Stalin's and Vladimir Lenin's. Dictators that oppressed, killed, and committed the genocide of millions of my people. Members of my Ukrainian family suffered and perished under their communist policies, and the echoes of that trauma still haunt me today. Phrases like "Manifesto" and "Revolution," combined with the image of the raised fist on Kavi's promotional fliers, undeniably mirror the propaganda of that horrific era, and I felt a wave of fear wash over me. As a Ukrainian with trauma linked to communist regimes, I was left feeling unsafe and targeted in a space that should have been

neutral and secure. I've attached images from Kavi's "Manifesto" as evidence, clearly showing the disturbing parallels to communist propaganda. The fact that both candidates chose to employ such reckless and menacing language—evoking mass killers who devastated my family and countless others—only deepens my sense of unease. Their actions don't just break the election code; they create an intimidating atmosphere that no one should have to endure during a simple school election. Given their flagrant disregard for the rules and the unease they've instilled in me through their dangerous rhetoric, I strongly believe that Kavi and Naim's behavior warrants immediate disqualification. I cannot shake the feeling of vulnerability this has left me with, and I urge you to address this matter with the seriousness it demands.
